- **Entry form and deadline:** All participants must fill out an official entry form. Entry deadline is Tuesday June 3, 2009, 6:00pm -\$15.00 fee will be charged for any late entries.
- **Starting times:** June 4, 2009: after 8:00pm. All Doubles, except Mixed divisions will be Saturday June 6th. All Singles and Mixed Divisions will be held on Sunday June 7.
- **Check-in:** 30-minutes prior to match. 15-minute forfeiture rule will be in effect.
- **Membership:** World Outdoor Racquetball (WOR) membership required. Fee for new members or renewal is \$15.00. Tournament shirt provided for all entrants. Late entries may not receive shirt.
- **Refereeing/officiating:** All winners MUST referee.
- **Prizes/awards:** Prize money for Men's/Woman's Pro Divisions, and Upper Mixed Division. Prize money will be dependent upon number of entries. Prizes from Ektelon for all other divisions. **Players receiving cash awards will be responsible for any taxes.**
- **Hospitality:** Food and beverages will be available for all participants.
- **Seeding:** All division seeding based upon current WOR ranking points.
- **Quadrant serving:** Will be in effect during singles division play.
- **2 division maximum per player. Emerging Players (EP) are classified as players who are new to outdoor racquetball racquetball, but NOT specifically the player's first time playing outdoor. More specifically, an EP must not have ever played in a WOR-Sanctioned Event, where WOR points were given.**

Tournament director reserves the right to combine or cancel division(s) due to insufficient number of entries.

- **Eye protection must be worn during game play. Players refusing to wear eye guards may be subject to forfeiture from the tournament.**
- **The Tournament Director reserves the right is disqualify an participant who does not follow *Code of Conduct*, as established by WOR.**

CODE OF CONDUCT

THE FOLLOWING GUIDELINES ARE CONSIDERED MINIMUM ACCEPTABLE CODE OF CONDUCT AND GENERAL PLAYER AGREEMENT

In the interest of fostering excellence and promoting integrity in the game of outdoor racquetball, the WOR council have prepared the following Code of Conduct for all WOR-Sanctioned tournaments and shootouts.

1. *WOR events are not exclusively for the players. Families, parents, grandparents, including children are usually present at our events. Therefore, excessive profanity will not be tolerated. Players, who use profanity, will be given one (1) warning. If the player violates this warning he/she will be disqualified from the specific event.*
2. *Fighting will not be tolerated. Any players observed participating in fighting at a WOR-Sanctioned event will be automatically disqualified from the event. (No exceptions)*
3. *In order to preserve and maintain the ethical boundaries of players, and the organization, any player(s) found participating in gambling or paying other players in order to gain advantage during a sanctioned event, will be immediately disqualified from the event. This decision to disqualify the player(s) will be made by the director of the event, or by a council of his/her choosing. .*

WOR MISSION STATEMENT

WOR will work to bring outdoor players throughout the world into the mainstream of racquetball through affiliation with the USAR.
